<b>Early Years Funding</b>
We are a registered provider for Surrey County Council Funding for 2, 3 and 4 year olds and are able to offer 15 hours entitlement under the scheme. Funding applied is dependent on child's age and sessions chosen. Those signing up for year-round provision (49 weeks per year) are permitted to stretch this entitlement across the year, which equates to 11 hours' free funded childcare per week. Details are available from the Finance Team.
<b>Childcare Vouchers and Tax Free Childcare</b>
We accept childcare vouchers which are a tax efficient way of paying for some fees and charges. Some employers offer this benefit. Childcare vouchers can be used for: <ul style="list-style-type: none"> <li>• Nursery fees</li> <li>• Kindergarten fees</li> <li>• Reception fees up to the term of the child's fifth birthday</li> <li>• After school activities</li> <li>• After school care</li> </ul> We are also registered for Tax Free Childcare, the tax efficient Government Scheme. Details are available from the Finance Team.
<b>Sibling Discount</b>
The sibling discount effective from January 2025 has been increased to 5% for the second child, 10% for the third child and 20% for the fourth child and any further siblings. This has also been extended to benefit parents who have one or more children at any of the three schools in the Bridewell Foundation: Longacre, Barrow Hills and King Edward's.
<b>Registration Fees and Deposits</b>
A non-refundable fee of £180 (including VAT) is payable upon registration. A deposit of £500 (VAT not applicable) is payable upon acceptance of a place and is refundable when the child leaves.
<b>Fees and Payment</b>
Payment for year round provision has been spread across six payments over the year. Payment is due for all year groups on the first day of term, or first day of holidays, by direct debit.  A monthly payment plan is available by arrangement with an external provider.  Longacre operates a fees in advance scheme, to provide a method where the cost of independent education can be reduced by making an advanced lump sum payment. The minimum number of terms payable to qualify under this scheme is six terms.  Details of both the above are available from the Finance Team.
<b>Personal Accident Insurance</b>
As an additional benefit Longacre provides personal accident insurance for no extra cost to cover all children. The terms of the policy are available upon request from the Finance Team.
